



IMPORTANT - PLEASE READ BEFORE REGISTERING A PLAYER

Supplier and Recreational Services

Supplier: Mooroolbark Soccer Club Inc. (the Club), including its directors, committee members, officers, employees, volunteers, coaches, referees, marshals, contractors, agents, sponsors and event partners.

Recreational services: The Red Earth Summer Slam 2026, including all 5-a-side football matches, warm-ups, finals, presentations, event activities, attendance at Esther Park and any related services or activities conducted or arranged by the Club.

Warning Under the Australian Consumer Law and Fair Trading Act 2012

If you sign this form, you will be agreeing that your rights to sue the supplier under the Australian Consumer Law and Fair Trading Act 2012 are excluded, restricted or modified in the way set out in this form, if you are killed or injured because the services provided were not in accordance with the statutory guarantees outlined below.

Under the Australian Consumer Law (Victoria), several statutory guarantees apply to the supply of certain goods and services. These guarantees mean that the supplier named on this form is required to ensure that the recreational services it supplies to you-

- are rendered with due care and skill; and
- are reasonably fit for any purpose which you, either expressly or by implication, make known to the supplier; and
- might reasonably be expected to achieve any result you have made known to the supplier.

Under section 22 of the Australian Consumer Law and Fair Trading Act 2012, the exclusion of these statutory guarantees is brought to your attention by this form.

NOTE: The change to your rights, as set out in this form, does not apply if your death or injury is due to gross negligence on the supplier's part. Gross negligence, in relation to an act or omission, means doing the act or omitting to do an act with reckless disregard, with or without consciousness, for the consequences of the act or omission. See regulation 5 of the Australian Consumer Law and Fair Trading Regulations 2012 and section 22(3)(b) of the Australian Consumer Law and Fair Trading Act 2012.

Assumption of Risk and Parent/Guardian Responsibility

I acknowledge and agree that football, including 5-a-side football, is a physical sporting activity and involves inherent and obvious risks. These risks include, but are not limited to, slips, trips, falls, collisions with other players or equipment, tackles, impacts from the ball, cuts, bruising, sprains, strains, fractures, dislocations, concussion, heat illness, dehydration, illness, aggravation of existing conditions, property loss or damage, and in rare cases serious injury or death.

I confirm that the player is participating voluntarily and that I am responsible for determining whether the player is medically and physically fit to participate. I agree to provide the Club with accurate details of any medical conditions, allergies, medication needs, restrictions or other matters that may affect the player's safe participation.



I acknowledge that I remain responsible for the player's supervision, behaviour and welfare when the player is not actively participating in a match or activity under the direct control of competition officials or team officials. I agree that the player and I will follow all reasonable directions of Club officials, referees, marshals, coaches and volunteers.

Accident, Injury, Illness, Insurance and Costs

To the fullest extent permitted by law, I acknowledge that Mooroolbark Soccer Club Inc. is not responsible for any accident, illness, injury, death, loss, damage, cost or expense sustained by the player, me, or any spectator connected with the player while participating in, travelling to or from, or attending the Red Earth Summer Slam 2026.

I acknowledge that any insurance attached to the event, club registration, Football Victoria or any governing body may be limited and may not cover all medical, ambulance, dental, rehabilitation, physiotherapy, hospital, income, property, travel or other expenses. I accept full responsibility for arranging and maintaining any private health insurance, ambulance cover, personal accident insurance or other insurance that I consider necessary for the player.

I agree that I am solely responsible for all medical, ambulance, hospital, treatment, rehabilitation, transport and related costs arising from the player's participation or attendance, except to the extent that such costs are covered by any applicable insurance or cannot lawfully be transferred to me.

Medical Treatment and Emergency Consent

I consent to the Club, its officers, volunteers, coaches, referees, marshals or event staff arranging first aid, medical treatment, ambulance transport or emergency assistance for the player if they consider it necessary or appropriate.

The Club will use reasonable efforts to contact me and/or the player's emergency contact before arranging non-urgent medical treatment where practicable. I understand and accept that in an emergency this may not be possible and that treatment or transport may be arranged without prior consent.

I agree to reimburse or pay directly any costs associated with medical attention, ambulance transport or other emergency assistance arranged for the player, except where the Club is required by law to meet those costs.

Release, Waiver and Indemnity

To the fullest extent permitted by law, I release, discharge and hold harmless Mooroolbark Soccer Club Inc. and its directors, committee members, officers, employees, volunteers, coaches, referees, marshals, contractors, agents, sponsors and event partners from all claims, demands, actions, proceedings, liabilities, losses, damages, costs and expenses arising out of or in connection with the player's participation in, or attendance at, the Red Earth Summer Slam 2026.

To the fullest extent permitted by law, I indemnify Mooroolbark Soccer Club Inc. and its directors, committee members, officers, employees, volunteers, coaches, referees, marshals, contractors, agents, sponsors and event partners against any claim, demand, action, proceeding, liability, loss, damage, cost or expense arising from the player's participation, the player's conduct, my conduct, any breach of this form, or any inaccurate information provided by me.

Nothing in this document excludes, restricts or modifies any liability that cannot lawfully be excluded, restricted or modified, including liability for gross negligence where applicable.



Rules, Conduct and Behaviour

I agree that the player and I will comply with the rules of Mooroolbark Soccer Club Inc., the Red Earth Summer Slam competition rules, venue rules, referee and marshal directions, and any Football Australia, Football Victoria or club codes of conduct that apply.

I acknowledge that the Club may refuse registration, suspend participation, remove a player or spectator from the venue, or take other reasonable action where behaviour is unsafe, abusive, discriminatory, threatening, disrespectful or contrary to the values and rules of the Club or the competition.

Photography, Video, Audio and Promotional/Commercial Use Consent

I acknowledge and agree that Mooroolbark Soccer Club Inc. reserves the right to have photographs, video footage and audio recordings captured at the Red Earth Summer Slam 2026, including footage and images of players, teams, spectators, volunteers, officials, presentations, matches and event activities.

I consent to Mooroolbark Soccer Club Inc. capturing, storing, editing, reproducing, publishing and using photographs, video footage and audio recordings of the player and/or me for club, event, promotional, marketing, media, social media, website, broadcast, archival, sponsor and commercial purposes, without payment or further approval.

I understand that images and video may be used in future club promotions, advertisements, social media posts, printed materials, digital publications, sponsor-related content and other commercial or promotional material connected with Mooroolbark Soccer Club Inc., the Red Earth Summer Slam or club activities.

The Club will make reasonable efforts to use images and video respectfully and appropriately. If I have a child safety, court order, privacy or other serious concern about image or video use, I must notify the Club in writing before the player participates. I understand that, because the event is held in a public sporting environment, the Club may not be able to prevent all incidental capture of the player in crowd or match footage.

Privacy and Information

I consent to the Club collecting and using the player's and my personal information for registration, competition administration, fixtures, communications, emergency response, insurance-related administration, child safety, incident reporting, volunteer coordination and event management.

I warrant that the information provided by me is accurate and complete and that I will notify the Club promptly if any relevant details change.
