

PIRATES YOUTH RUGBY INDEMNITY & WAIVER FORM



Purpose

This document accompanies the online registration completed via the SportsPlus platform for participation in Pirates Youth Rugby Activities.

This document serves as the formal indemnity and acknowledgement notice relating to the online registration. By acknowledging and signing the consent box, the parent or legal guardian confirms that they have read and understood the contents of this indemnity and acknowledgement, they accept and agree to the terms contained herein as part of the players participation in Pirates Youth Rugby Activities.

This forms part of the registration record and consent provided through the SportsPlus registration system.

Acknowledgement of Risk, Indemnity and Waiver

I acknowledge that participation in rugby and related club activities inherently involves physical contact and carries risks of serious injury, including permanent bodily injuries. These risks may arise from my child's own actions, or the actions of others.

I hereby indemnify Pirates Youth Rugby, Pirates Rugby Club, Pirates Club, and all associated persons or entities ("the Club") from any liability, claims, loss, or injury (to person or property), howsoever arising, sustained by my child or their property while:

- On Club premises.
- Participating in any trial training session or club-sanctioned activity.
- Under the control or supervision of Club staff, coaches, volunteers, or agents.

Medical Responsibility and Consent

I accept full responsibility for any medical or hospital costs if my child is injured during Club activities, and consent to them receiving treatment from qualified paramedics if needed.

Duration and Applicability

This indemnity shall be valid from the date of signature and shall remain in full force and effect for the duration of my child's participation in Pirates Youth Rugby.

Conduct and Rules

I confirm that my child and/or I have read and understand the BokSmart and Pirates Youth Rugby Codes of Conduct for players and spectators and agree to abide by them. I acknowledge that no alcohol is permitted on the field, no unauthorised persons are allowed on the field of play during practices or matches, and that weapons are strictly prohibited. We accept all safety requirements.

Waiver of Claims

I waive any claim that I or my child may have against the Club or its representatives for injury, loss, or damages arising from rugby participation, whether due to negligence or otherwise, and indemnify them against all such claims.

Parental Responsibility Before and After Activities

I acknowledge that Pirates Youth Rugby cannot supervise players before or after any official practices or matches. I accept full responsibility for ensuring my child is collected promptly and remains supervised outside of these times.

Health Disclosure

The parent or legal guardian confirms that all relevant pre-existing or current medical conditions, injuries, allergies, medications, or physical limitations affecting the player have been fully and accurately disclosed within the registration process.

The parent or legal guardian further undertakes to notify Pirates Youth Rugby of any changes to the player's medical condition during the season.



Pirates Youth Rugby, and its officials, coaches, managers, and other volunteers shall not be held liable for any injury, illness, or medical complication arising from a condition that was not disclosed or was inaccurately disclosed at the time of registration or such time during the season where it became known.
