

AMATEUR ATHLETIC WAIVER AND RELEASE OF LIABILITY ***** (READ BEFORE SIGNING) *****

- In consideration of being allowed to participate in any way in YOUTH CRICKET LEAGUE with TCLNC and related events and activities, the undersigned acknowledges, appreciates, and agrees that:
- The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
- As a parent of the participating child, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,
- As a parent of the participating child, I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,
- As a parent of the participating child, I, for myself, for my participating child and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS Triangle Cricket League NC Corporation, their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law; and,
- **EXPRESS ASSUMPTION OF RISK:** UNDERSIGNED (parent of the participating child) hereby acknowledges and understands that the World Health Organization has declared COVID-19 a worldwide pandemic. COVID-19 is extremely contagious and spreads mainly from person-to-person contact. Based on currently available information and clinical expertise, older adults and people of any age who have serious underlying medical conditions may have a higher risk for severe illness from COVID-19. There have been recommended guidelines and preventative measures put in place to reduce the spread of COVID-19 in society; however, TCLNC CANNOT GUARANTEE that the participant will not become exposed to or infected with COVID-19. Furthermore, participation by participant in the Events could increase participant's risk of contracting COVID-19. By signing this Agreement, UNDERSIGNED acknowledges the extremely contagious nature of COVID-19 and voluntarily assumes the risk that the participant may be exposed to or infected with COVID-19 from participation in the Events, and that such exposure or infection may involve the RISK OF SERIOUS INJURY, ILLNESS, PERMANENT DISABILITY AND/OR DEATH. UNDERSIGNED understands that the risk of becoming exposed to or infected with COVID-19 by UNDERSIGNED's participation in the Events may result from the actions, omissions, or negligence of others and/or UNDERSIGNED, including, but not limited to, the RELEASEES (as defined below). UNDERSIGNED hereby expressly assumes all such risks and dangers whether presently known or unknown; and,
- As a parent of the participating child, I willingly agree to comply with the guidelines prescribed by the league relative to the COVID.

- As a parent of the participating child, I willingly grant permission and consent to TCLNC for the use of photos/videos/any electronic media for presentation under any legal use

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.

Code Of Conduct

Play your part and observe TCLNC's Respect Code of Conduct for players at all times. As parent of a participating child, I will assume responsibility for my child

- Adhere to the Laws of The Game
- Display and promote high standards of behavior
- Promote Fair Play
- Always respect the match officials' decisions
- Never engage in public criticism of the match officials on field
- Never engage in offensive, insulting or abusive language or behavior
- Never engage in bullying, intimidation or harassment
- Speak to my team-mates, the opposition and my coach/manager with respect
- Remember we all make mistakes.
- Win or lose with dignity. Shake hands with the opposing team and the referee at the end of every game.

I understand that if my child does not follow the Code, any/all of the following actions may be taken by my child's club, league or organization: My child may:

- Be required to apologize to team-mates, other team, referee
 - Be dropped or substituted or coach.
 - Be suspended from training
 - Receive a warning from the coach
 - Be required to serve a suspension
 - Receive a written warning from the TCLNC Enforcement committee
 - Be fined
 - Be required to attend a meeting with Enforcement Committee
 - Be required to leave the club
- In addition:
- The league could impose a fine or other sanction against his/her team for his/her violation of any of the above.
