

## **MASTER MULTI-SPORT PLAYER REGISTRATION AGREEMENT**

### **RELEASE OF LIABILITY, ASSUMPTION OF RISK, INTELLECTUAL PROPERTY RIGHTS, INDEMNIFICATION & TERMS OF PARTICIPATION**

This Master Multi-Sport Player Registration Agreement (“Agreement”) is entered into by and between Cultural Wealth Sports, LLC, including all affiliated entities, subsidiaries, foundations, sponsors, partners, officers, directors, commissioners, employees, volunteers, coaches, referees, facility providers, and agents (collectively “Cultural Wealth Sports”), together with its national program partners including but not limited to Reigning Champs Football LLC, the National Football League and its affiliates (collectively “NFL”), MLS GO and its affiliates, Jr. NBA and Jr. WNBA and their affiliates, MLB Pitch Hit & Run and their affiliates, and each of their respective parents, subsidiaries, affiliates, member clubs, business partners, sponsors, employees, officers, directors, owners, subcontractors, and agents (collectively, the “Releasees”), and the undersigned parent or legal guardian (“Parent/Guardian”) of the minor participant (“Participant”), or the Participant if over the age of eighteen.

By executing this Agreement, Parent/Guardian represents and warrants that he or she is the lawful parent or legal guardian of Participant, is of legal age, is signing freely and voluntarily without inducement, has read and understands this Agreement in its entirety, and understands that by signing this Agreement certain substantial legal rights, including the right to sue, are being waived. Parent/Guardian agrees that the terms herein are binding upon Parent/Guardian, Participant, and their respective family members, heirs, estate, successors, and assigns.

This Agreement applies to participation in all Cultural Wealth Sports programs, including but not limited to NFL FLAG Football (including regional and national tournaments), MLS GO Soccer, Jr. NBA, Jr. WNBA, MLB Pitch Hit & Run, camps, clinics, showcases, combines, tournaments, travel events, practices, games, scrimmages, strength and conditioning sessions, use of facilities, and any related events (collectively, the “Program”).

In consideration for Participant being permitted to participate in the Program, Parent/Guardian, on behalf of himself or herself, Participant, and all related parties (collectively, the “Releasers”), hereby fully and forever releases, waives, discharges, and agrees not to sue the Releasees from any and all present or future liabilities, claims, demands, causes of action, damages, losses, costs, or expenses of any kind, whether known or unknown, suspected or unsuspected, at law or in equity, arising from or related to Participant’s participation in the Program, wherever and however such participation occurs. This release includes, without limitation, claims for personal injury, property

damage, permanent disability, illness, concussion, traumatic brain injury, death, wrongful death, or other damages, even if caused in whole or in part by the ordinary negligence of any of the Releasees.

Parent/Guardian acknowledges that participation in youth sports involves inherent risks including, but not limited to, physical contact, collisions, falls, equipment failure, field or facility hazards, heat illness, dehydration, concussion, serious bodily injury, permanent disability, or death. Parent/Guardian voluntarily assumes all risks associated with participation and certifies that Participant is in good physical condition and capable of participating in strenuous athletic activity.

Parent/Guardian agrees to indemnify and hold harmless the Releasees from and against any and all liabilities, claims, damages, costs, or expenses, including reasonable attorneys' fees, arising out of or related to Participant's participation in the Program, including any medical treatment rendered.

Parent/Guardian hereby grants permission for Participant to receive emergency medical or dental treatment, first aid, and hospitalization if necessary during participation. Parent/Guardian authorizes Cultural Wealth Sports and its designated medical providers to arrange and consent to such care and acknowledges responsibility for all resulting medical expenses. Parent/Guardian agrees to the release of medical records for insurance purposes if necessary.

Parent/Guardian acknowledges and agrees that Cultural Wealth Sports and its national partners exclusively and perpetually own and control any and all rights to photograph, videotape, record, broadcast, reproduce, publish, distribute, or otherwise exploit Participant's name, likeness, voice, image, statistics, biographical information, uniform, and performance in connection with the Program in any and all media now known or later developed, for any lawful commercial, promotional, advertising, or operational purpose. Parent/Guardian grants an irrevocable, royalty-free, worldwide license for such uses without compensation.

Parent/Guardian represents and warrants that he or she has full legal authority to complete registration and act on behalf of Participant. Parent/Guardian acknowledges compliance with the Children's Online Privacy Protection Act (COPPA) and consents to the collection and use of Participant's personal information consistent with applicable privacy policies.

Parent/Guardian acknowledges that participation in the Program and use of any associated websites is at Participant's and Parent/Guardian's sole risk. The Program and related digital platforms are provided "as is" and "as available" without warranties of any kind, express or implied. The Releasees disclaim all warranties including, but not limited to,

merchantability, fitness for a particular purpose, and non-infringement. The Releasees shall not be liable for any direct, indirect, incidental, consequential, or special damages arising from participation or use of associated digital platforms.

Parent/Guardian acknowledges that all trademarks, logos, names, symbols, designs, and intellectual property associated with the NFL, MLS, NBA, WNBA, MLB, Reigning Champs, and Cultural Wealth Sports (collectively, the “Marks”) are the exclusive property of their respective owners. Parent/Guardian agrees not to use such Marks without prior written authorization and acknowledges that unauthorized use may cause irreparable harm and entitle the owners to injunctive relief.

This Agreement is intended to be as broad and inclusive as permitted by applicable law. If any provision is held invalid or unenforceable, the remaining provisions shall remain in full force and effect.

This Agreement shall be governed by the laws of the State of Florida for Cultural Wealth Sports operations, except where national program terms require otherwise.

Parent/Guardian consents to exclusive jurisdiction and venue in Florida courts for disputes relating to Cultural Wealth Sports operations, and to Illinois jurisdiction where required under NFL FLAG national terms.

Parent/Guardian expressly waives all rights under Section 1542 of the California Civil Code and any similar law of any jurisdiction, acknowledging that this release applies to known and unknown claims, whether suspected or unsuspected. Parent/Guardian understands that he or she may later discover facts different from or in addition to those currently known but agrees that this release shall remain fully binding notwithstanding such discovery.

By signing or electronically accepting this Agreement, Parent/Guardian affirms that he or she has read and understands this Agreement in its entirety, understands that substantial legal rights are being waived, including the right to sue, and voluntarily agrees to be bound by its terms to the fullest extent permitted by law.
